**No. PEM.83/2009/Pt-VII-A/39 :-** In exercise of the powers conferred by Subsection (1) of Section 15 and Section 23C of the Mines and Minerals (Development and Regulation) Act, 1957 (67 of 1957), the Governor of Assam is pleased to make the following Rules further to amend the Assam Minor Mineral Concession Rules, 2013 hereinafter referred to as principal Rules, in the manner hereinafter appearing, namely :-

- Short title and commencement
1. (i) These Rules may be called the Assam Minor Mineral Concession (Amendment) Rules, 2015.
  - (ii) They shall come into force on the date of their publication in the Official Gazette.
2. In the principal Rules, for the existing First Schedule, the following shall be substituted, namely :-
